

Safeguarding Survey Privacy Notice

Introduction

This privacy notice explains how the Council uses your data to get adults at risks views on the quality of the safeguarding intervention delivered by the local authority and partner agencies.

Who will be using your data?

Nottinghamshire County Council will be the data controller for the data you provide to us.

We may also contract third party organisations to process your data on our behalf.

What personal data do we use?

- Name and Contact Details
- Age
- Date of Birth
- Gender
- Address
- Social Care ID
- Family details
- Parent/carer details
- Personal appearance and behaviour
- Case file information
- Nine protected characteristics

What types of special category personal data do we need from you?

- Racial or ethnic origin
- Trade Union membership
- Advocacy details
- Social care support outcomes
- Physical and mental health details
- Data concerning sex life or sexual orientation
- Religious, philosophical or other beliefs of a similar nature

Why do we use your data?

- For service delivery
- For service planning, training and improvement
- To inform and improve partnership working with wider agencies.

What legal reasons allow us to use your data in this way?

Our legal basis for processing your personal data is to meet statutory requirements set out in the Equality Act 2010 and Care Act 2014.

Our legal basis for processing your special category personal data is to meet the above requirements but will involve the person through consent or best interest as outlined in the Mental Capacity Act 2005.

Who may we share your data with or receive it from?

- Health Watch
- Nottinghamshire Safeguarding Adults Board Sub Committee and statutory partners.
- Safeguarding Adults Governance Group.

May personal data be transferred overseas?

The Council may for operational purposes transfer personal data overseas. In these cases, we will ensure that your personal data is protected and there are safeguards for the protection of your rights. Please refer to the Council's privacy statement for further details.

How long is your data kept for?

This information is held in accordance with the Council's retention schedule – see <u>here.</u>

What will happen if you do not provide or we cannot obtain the data needed?

 We could not learn about the standard of service delivery to support adults at risk and improve our approach based on the Care Act 2014 six principles.
 Without special category information the local authority could not monitor and provide corrective action if variances are identified in the satisfaction levels when analysing against specialist categories.

Does the service make decisions using fully automated processes?

What rights do you have over this use of your data?

- To be informed about how we use your data
- To access a copy of your data that we process
- To have us rectify or correct your data that we process
- To restrict our processing of your personal data
- To object to the use of your data
- To have your personal data erased
- To request that we transfer your information to you or another organisation

- To object to fully automated decision making
- To withdraw your consent (if it the legal reason why we use your data).

Some of these rights are subject to exceptions. Please refer to the <u>County Council's</u> <u>privacy statement</u> part 10 for further details.
